The Board and various committees are working on a number of projects intended to enhance your membership in the USKBTC. We have formed a committee with the purpose of obtaining approval for KBTs in Earthdog and Herding events, both part of the heritage and utilization of the Kerry in Ireland. This, in my mind, is part of our responsibility for preserving and protecting the essence of the breed and will open up new opportunities for members to enjoy their Kerrys! This committee is composed of members who enjoy and participate in these events. There is interest in Strong Dog events, but at this writing it's not clear that it is offered by the AKC.

The Judge Selection Review Committee is wrapping up their work, and a recommendation will be made to the Board on improving and insuring the transparency of the election process. The new process will be reviewed by the Board and explained to members before we commit to judges beyond 2007. Valid contracts are currently signed through 2007.

Thanks to Carol Kearney's continuing efforts and Fred Fishell's generosity, **Kerrytoons** will soon be published in book form. These will be available at Montgomery. Fred intends to donate the profits from the sale of the book to Charitable Funds and plans to be on hand to autograph copies.

Our Communication and Publicity committee has developed banners, displayed elsewhere in this issue of Blueprints, suitable for shipping-in tubes- to the chapter clubs for display at regional specialties and large shows. These will go a long way towards educating the general public about our breed. In addition, the committee is creating a new pamphlet which will include detailed information on Kerry Blue Terriers and Club activities. The brochure, which can be used by chapter clubs, will be based on one developed by Reita, Melanie and Debbie for the Kerry Blue Terrier Club of Chicago.

The AKC and the USKBTC encourages all members to microchip their dogs. We offer microchip clinics at several specialties and it's available at many events. You cannot OFA your dogs without them first being micro-chipped or tattooed. For the safety of the dogs and your own piece of mind **MICROCHIP!**

The lifeblood of any organization is the participation, development and continued interest of young members. Sarah LaGossa and her daughters, Marie and Shannon, are researching the development of a junior handling awards program to encourage and recognize junior handlers in our breed.

## **AKC's NEW CODE OF SPORTSMANSHIP**

New York, NY - The American Kennel Club Board of Directors, as a result of the Chairman's Committee on Conflict of Interest, approved at its February meeting the first-ever written Code of Sportsmanship for the sport of purebred dogs.

According to AKC Chairman Ron Menaker in his February Chairman's Report, he hopes, "everyone in the fancy will take time to read and practice the new code and appreciate the value a Code of Sportsmanship adds to the experience of being a member of 'the fancy.'"

The following is the new AKC Code of Sportsmanship in its entirety:

### **AKC Code of Sportsmanship**

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of his breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.

**Cross Training The Kerry Blue Terrier –  
A State of Mind** by Jane Eno

When I got my Kerry Blue Terrier eight years ago, I started to pursue both obedience and agility training. At that time I also became aware of the extremely successful team of Eve Fishell and CH OTCH Tantara's Blue Streak Am UD, Bd CD, AG.N., MXJ, MX, OAC, OJC, NGC, VE-AC, ADC, VAADC, PD1, ROM (Streaky). Eve's work with Streaky became my role model for what a Kerry Blue Terrier should become and I have tried to live up to that standard.

What impressed me the most about this team was the excellence in many different venues they had achieved. Not only has Streaky won a Championship, but also her Canadian OTCH, and her Master Agility Titles. Somehow she even found time to whelp four litters of puppies! She truly was a master of all she tried.

In more recent years we have seen some new Kerries achieve prestigious awards in multiple disciplines. For example, Brian and Diane Kincaid's CH MACH Kerigolf Flower Power (Daisy), became the first Kerry to have two championships by adding a Master Agility Champion title on top of her conformation Champion. In 2004, Chris Cagle's CH Rosegarden's Vagabond Star VCD1 (Cailin) became the first Kerry to achieve one of the new Versatile Companion Dog titles from the AKC. For this title the dog has to win titles in obedience, agility and tracking, but Chris went one step further by also finishing a championship on his Kerry.

The United States Kerry Blue Terrier Club now recognizes dogs like these that have achieved success in multiple venues with the Versatility Awards. These awards are presented each year to Kerry Blue Terriers that title in more than one discipline from a wide range of opportunities: conformation, obedience, agility, earthdog/hunting, flyball, herding and tracking.

In my own experience, I have found that the issues around cross training the Kerry Blue Terrier lie in the mind of the handler more than in the dog. As I have crossed over to different venues, I have found myself interfering with my dog's

natural abilities because I have tried to make my training conform to ideas I have brought from other sports. My own Kerry, Jessie, has competed in Obedience and Agility, plus participated in earthdog and herding. Tracking is our next venue we wish to pursue.

The first 7 years of training, I primarily concentrated on obedience, only running agility for fun and relaxation. After we had completed our Utility Dog Excellent title in obedience, my goal was to really concentrate on achieving more in agility. I had to let myself see the differences in the two sports and change my mindset for agility. Obedience has always been about control and attention to detail for us. Each crooked front, poor finish, or loss of focus was fixed at once and drilled out of the performance as much as possible. When I started trying to title in agility, I approached it the same way and got accurate, but slow runs. Jessie did what I wanted. He is a good team member and always tries hard. I had to realize that agility is more about speed and independent thinking than the precision of obedience. I had to learn to let him knock a bar, miss a weave pole, or blow an entry as long as he showed the spirit and speed I was so hoping for. Once I did that, I suddenly could see what both sports had in common. They are both primarily about attitude and teamwork. As long as you are working as a team with your Kerry Blue Terrier, and you both have a positive attitude about the game you are playing, you can achieve your goals.

The week after Jessie finished his UDX, I also signed him up for herding classes as a reward for his hard work. I knew he had the basic instinct after we had tried herding ducks years ago. I did not know if his instinct for this activity would still be there almost 6 years later. Once again, I had a hard time adjusting my thinking to this very different venue, while Jessie had no problem at all. In herding, Jessie knew what he was doing, and this time I was student and the one doing the learning. I had to learn to read sheep (something Jessie already knew), I had to learn to trust Jessie (something that came very hard), and I had to learn how to help him without

## **Why Attend The National?**

Are we guilty of over-emphasizing our National each year? No way!! The National is the most valuable learning experience on the breed that a fancier can treat himself to. The following benefits listed, although not intended to be all-inclusive, are some that come to mind to this writer as being important enough to warrant consideration of making an effort to attend our National.

1. If you are showing and doing your share of winning, say in a two to five state area, chances are it has become easy to believe that your own breeding program is as good as it needs to be. This complacency, so detrimental to growth and improvement, can receive a jolt of realism when you attend the National and see that a breeder from across the nation managed to achieve better top lines, as an example, from similar foundation stock.
2. Since most of the top-ranked dogs will be there (if the owners are smart!), you will have the opportunity to see in person and to study up close those animals whose ads have caught your eye. Hopefully, you will be able to meet their owners and visit about incorporating them into your breeding program, if that is your goal. Don't mislead the owners, be honest if you are simply only "shopping" or considering, and haven't made a decision yet. It is especially beneficial to arrange to see the dogs in their motel room. Although it shouldn't be construed as a final temperament test, interacting with a dog on a one-to-one basis in an area with which they have become somewhat comfortable is more reliable than jumping on that dog right outside of a show ring. It should enable one to learn more about its personality than merely seeing it in a show ring environment.
3. Although fanciers are often hesitant to share their breeding problems and setbacks through articles and journals, or newsletters, they are often willing to discuss them in person with other concerned fanciers.
4. The non-regular classes offered at specialties provide learning experiences for the observer. Stud dog and brood bitch classes give evidence of the varying degree of prepotency possessed by our leading brood stock, while veteran classes bring life to pedigrees and year book photos. They also leave the sentimental misty-eyed watching the stars of the past gait proudly once more as an admiring audience cheers.
5. If you go to the National as an exhibitor, be prepared to consider any sort of win as simply icing on the cake. Simply placing in a class is an honor at the National, and there are many who feel that even "making the cut" in a class is an honor! More so than going there to win, go to learn and to socialize.

Granted, showing your dogs at the National can be a very humbling experience. It is, however, a chance to see how your dogs rate with others from around the country. You could be in for a pleasant surprise, but of course you can also be in for a rude awakening! Going to the National gives a person new perspective. It's a chance to see where the breed is headed, and what areas need improvement. Another point: dogs that are regarded highly may prove to be disappointing to you, once we have seen them move, how they show, or some other detail that a photo does not reveal. Watching your Super Special perform in the ring has altered many a direction in a breeding program. If a picture is worth a thousand words, then BEING THERE in person must be worth a million!

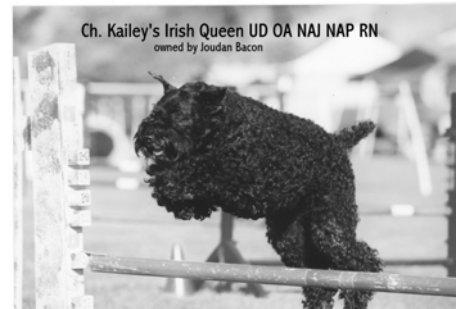

"At 12 years old, Kailey is still competing successfully! She was born September 27, 1992 and started her show career with classes in conformation and obedience. Her coat did not change color quickly, so she didn't finish her championship until she was almost four years old. In the meantime she started competing in obedience and achieved her CD title two months before her championship, May 4, 1996. She earned her Utility title May 3, 2003 on a rainy, ground soaked day when many dogs withdrew from competition. While she was working toward her UD she started Agility (at 8 years old) and got her Novice title in May 2001. At age 12 she received her Novice Agility Preferred title. She is now competing in Rally and has earned her first title in this new competition."



Ch. Kastle's Unforgotten Promise CD, CGC, TDI owner's, Nanette Loya and Casie Ward submitted the following:

"Promise", born in 1991 and bred by John and Judy Schlotzhauer is still going strong and living out the remainder of her life with a family that adores her. She is truly the versatile terrier, wanting to do everything, no matter what was asked of her. She excelled in the conformation ring, the obedience ring and Agility. "Andy's breeder, Margaret McDonough introduced me to this smart, funny sensible, hardworking, wonderful, devoted dog. He announced himself as mine by climbing onto the sofa next to me and putting his head in my lap within minutes of our first meeting..."

"Andy was ranked among the Kerry Blue Terriers in Obedience in Front & Finish Delaney ratings in 1999."

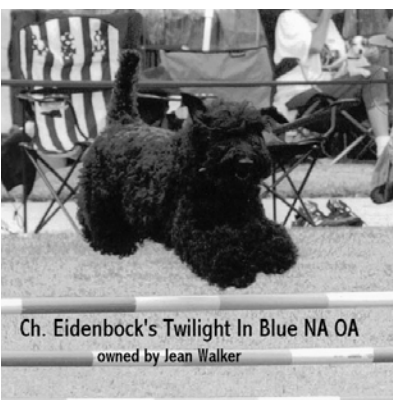
#### Commenting on Open, Utility, Agility and Rally:

The All-Terrier Agility trials held at Kimberton Pa just before Montgomery seemed like a congenial place to try this sport...Andy earned his NA with 2 firsts and a second place)

Virginia goes on to report that Andy completed both his Rally Novice and Rally Advanced titles in stylish fashion, earning high scores and class placements, including a score of 100 in RN.



Ch. Eidenbock's Twilight In Blue, NA OA began her training almost the day she went to her home, says her breeder Helen Eiden. She continues about owner Jean Walker and Twila's story:

One of our most familiar performance Kerry Blues, Casey's Lavish Mischief UDX NA CGC became Lisa Frankland's introduction into our wonderful breed. And what an introduction:

"Lav is my first Kerry and my introduction to the sport of dogs. Some of the highlights of his obedience career include earning his CDX in one weekend, becoming the breed's second UDX, two all breed High Combined awards. High in Trial and High Combined at Garden State All Terrier Club in 1998, OTCH points, national rankings, numerous high scoring Kerry and high scoring terrier in trial awards and 2<sup>nd</sup> place in the Terrier Group at the 1997 AKC Obedience Invitational. The trip to the Invitational was especially sweet because of the overwhelming support we received from members of the KBTCSC and KBTCNC. As I was a stay at home mom with two small children and an even smaller budget at the time we qualified, traveling to St. Louis from California seemed out of the question. But once Diane Lee got the word out, the Kerry people would hear nothing of the sort, raising enough money to pay our airfare and expenses! Who says that our breed clubs don't support obedience?"

Lisa goes on to describe Lav's "new career" in agility after retiring from obedience reporting that he easily earned his Novice Agility title and two legs on his Novice Jumpers before yet another family move sidelined training. She continues:

"His Boy Scout personality ("trustworthy, loyal, helpful, friendly...") has made him an ideal therapy dog and won over numerous fans to our breed. Lav normally loves everyone, dogs and animals alike and always insisted a stranger is simply a friend he hasn't met! As such he was a perfect introduction to Junior handling for my daughter and current dog show partner in crime, Meghan. Two fondly remembered events bookend this part of his life. First, a then 7 year old Meghan handling 10 year old Lav to Best Veteran at the large "B" match in Virginia in 2000. And finally a now 12 year old Meghan taking 15 year old Lav into the Veteran Sweeps at the KBTCSC specialty in June 2005. What's not to love about a dog like this?"



Maggie Hall always wanted a Kerry Blue Terrier and her dream was realized when she brought home a male puppy who eventually became Ch. Kallehan's Blue Moon Rising AX MXJ. Maggie writes:

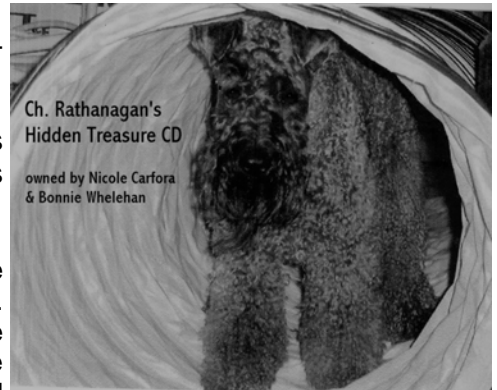

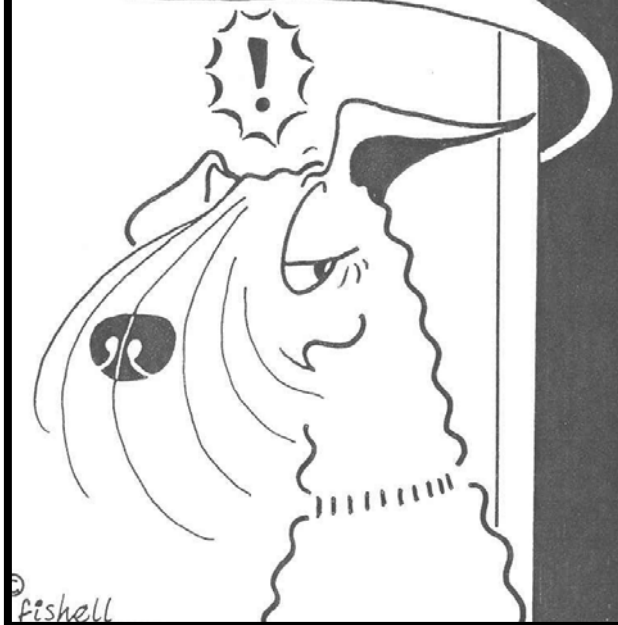

The American Kennel Club now offers a choice of Pet Healthcare Plans through a dedicated pet insurance provider, PetPartners, Inc. Under these plans, you can choose your own vet and receive benefits for many medical costs. If you choose a wellness plan, it assists in paying towards preventive care costs for annual checkups, vaccinations, dental cleanings and parasite control. The AKC Pet Healthcare Plan can give you peace of mind for the protection of your furry friend.

### **I Have a Healthy Dog—Why Do I Need Pet Insurance?**

The most compelling reason to buy pet insurance is to control costs associated with sudden injury or illness, which can occur at any stage of your pet's life. Young dogs frequently swallow things that they shouldn't, and sometimes need surgery. Active adult dogs love to run and jump, but are not aware of their own safety. As a breeder, you naturally want to be sure your puppies will be in good hands, and that their new owners will be financially able to provide excellent health care for them. Suggesting to your puppy buyers to consider pet healthcare insurance is a sensible way to encourage re-

The USKBTC Board of Governors established the United States Kerry Blue Terrier Club Charitable Funds, Inc in 2002, a 501c3 non-profit under the United States Internal Revenue Code. The formation of the Charitable Funds was the result of a lengthy and thorough evaluation of the status of the breed in the United States and the recognition that strategies were needed to ensure the long-term well-being of the Kerry Blue Terrier. The USKBTC is the official organization recognized by the American Kennel Club with the responsibility for protecting and promoting Kerry Blue Terriers in the United States.

The goal of the USKBTC Charitable Funds is to provide, in perpetuity, a safe, secure means for breeders, exhibitors, owners, and friends to contribute financial support for education, health and genetic research, and rescue efforts for Kerry Blue Terriers. The Charitable Funds is independent of the USKBTC Board of Governors but linked to our governing board through interlocking directorates. This arrangement assures that the Charitable Funds will be a permanent giving option to the Kerry fancy but will be buffered from the ebb and flow of fancier personalities and politics.

The professionally managed USKBTC Charitable Funds offers options for endowments as well as various funds of particular interest to donors. There is a permanent endowment fund to which a donor may make contributions the principal of which will remain permanently in an endowment fund. Donors are able to give to those efforts that matter most to them. Because the Charitable Funds is accountable to the USKBTC, donors know that management and distribution of your donations are monitored by the USKBTC through audits of the Charitable Funds.

There are 4 funds currently active in the Charitable Funds portfolio. In addition there are Memorial Funds that have been established to honor individuals with the proceeds generally going into one of the main funds. These funds are:

1. Rescue Fund – this fund supports grants used for USKBTC Kerry Blue Terrier rescue
2. Health and Genetics Fund - this fund makes grants in support of research in areas of health and genetics of particular importance to the Kerry Blue Terrier
3. Education Fund – the education fund supports education of all those interested in the Kerry Blue Terrier including publications, websites, and seminars
4. General Fund – donations to this fund are used to support the work of the other funds through internal grants to those funds. Undesignated gifts will initially be held in this fund.

In addition to the above there are currently 6 Memorial Funds: one in memory of Hank Friscone, long term member of the Northern Ohio Kerry Blue Terrier Club; the Machaven Memorial Fund in memory of Dr. Roger Macha, a long time Kerry Blue breeder and exhibitor; the Mary Anne Schaefer Memorial Fund, for her tireless work for the Kerry Blues and the USKBTC over many years; the Frank Sousa Memorial Fund, in honor of the impact Frank and Fralin Kerry Blue Terriers had on our breed; the Edith Izant Memorial Fund, in recognition of Edith's lifelong love of the breed; and the Charlotte Hart Memorial Fund, in memory of her dedication to our Kerry Blues.

## **The New Golden Goose**

"Guaranteed lucrative market in rescue groups say puppy millers..."

Selling to rescue organizations is becoming big business for puppy farmers. "A guaranteed market" one said with a wink. Another in the Southeast reported to USKBTC rescue just last week boasted, "I can sell these dogs to breed rescue. I heard they will pay big bucks for them."

Seed money to buy some other poor breed for his puppy factory? Or maybe even stock his shelves with more Kerry Blues to sell to a rescue organization? Even as this is written he's smacking his lips over the deal he's working out to sell these dogs to a rescue group.

Still another puppy factory in the Midwest who advertised a liquidation sale of Kerry Blue Terriers and gleefully watched rescue organizations jump, is said to be mysteriously back in business with more Kerry Blues. And why not? There's now a guaranteed market. When these shady characters know there's at least one organization willing to pay handsome prices for this stock, no matter how poor in quality, temperament or health, they don't hesitate to stock more merchandise.

What do fellow puppy factory breeders see when they come to auction? They see that selling to some rescue organizations will afford them a guaranteed lucrative market when pet stores won't anymore. They say to themselves, "Why bother with cocker spaniels when I can breed Kerry Blue Terriers, bring them to auction and guarantee making more money off that rescue group."

Then there's everyday Joe Blow factory breeder. He SAYS he's selling his Kerry Blue Terriers and getting "out of the breed" but he might just decide to hold a couple back, safely tucked away in the puppy factory at home. In a few more months he's back at the auction with another "going out of business" sale! And he does this confidently, knowing there will be at least one breed rescue willing to buy his dogs again at handsome prices.

What does this mean to the future of our Kerry Blue Terriers? It means that our breed is now a pawn being played in a game between the puppy millers/brokers and rescue. It means that these sly dealers in livestock are preying on the pure emotional response dog lovers have when their breed is in distress. This game is a form of "kidnapping" with our breed as the victims in-

cluding the traditional kidnapper's expectation of a hefty ransom.

It is the height of foolishness to give in to kidnappers. It only emboldens them to continue their game with other victims. When these dealers/brokers realize they can expect a guaranteed lucrative income from even one rescue organization they will continue to acquire and/or breed our Kerry Blues to take to auction or offer in quantity sales.

So what is the American Kennel Club's policy as it pertains to national breed rescues?

An excerpt:

The American Kennel Club discourages Parent Club rescue groups from purchasing dogs at auctions. Although Parent Clubs may be doing good things for individual dogs purchased at auctions, it perpetuates the problem and tends to create a seller's market. Reciprocally, auctioneers seek more dogs of those breeds to offer at auctions. AKC applauds the work of Parent Club rescue groups on many fronts. However, AKC believes that the purchasing of dogs at auctions is not overall in the best interest of purebred dogs.

Currently, the United States Kerry Blue Terrier Club has endeavored to ride down the middle lane, between the AKC's recommendation and a workable club policy implemented to rescue dogs at auction. USKBTC rescue developed a policy which endeavors to rescue as many Kerry Blues possible, but at the same time deprive dealers/factory breeders from real income from sales. Depriving these cold calculating business people from gaining any profit from selling Kerry Blue Terriers is the ONLY way to drive them away from our breed.

There have been half truths and complete lies told about USKBTC Rescue. USKBTC members have been rescuing Kerry Blue terriers for many years longer than some who spread this false information have even been involved with our breed. For the record, Joanne Schindler began the roots of "organized" rescue for the national club back in the 1970s...that's over 30 years ago. Kerry breeders were rescuing and placing the occasional dog (rescue dogs were few in those wonderful days) before that time. USKBTC rescue is one of the first organized national breed rescues in the country.

Since the early days, USKBTC rescue has operated with NO fanfare, NO self promotional back thumping,

or need for attention. Indeed, it was found efforts to be more effective when these puppy factories and brokers couldn't identify who was infiltrating their auctions or sales. USKBTC rescue determined that shouting out successes on unrestricted membership e-lists was not wise. Unrestricted e-list membership can include these brokers/puppy millers or more likely, their spies. To allow these "scouts" to go back and report club rescue tactics and the identity of those individuals who work to rescue from these auctions is seen as unwise at best, stupid at worst.

The USKBTC Rescue also determined that there should be a finite amount paid to buy a dog at auction or other sale. Regardless of what other propaganda has been spread, making Kerry Blues a money losing proposition for brokers/millers is the only way to put them out of business. Some may try to convince us that the law of supply and demand does not apply to buying dogs at auction, but nothing is further from the truth.

As difficult as it may be, being "cruel to be kind" may be the only way to take our breed away from these puppy brokers. By standing firm on a protocol designed to starve these brokers/millers out of our breed we will surely benefit the greater good of future Kerry Blues.

To quickly understand the law of supply and demand and the necessity of turning away, if sadly, from a dog at auction when the price goes too high, one offers this simple analogy:

Chocolate cake is flying off the shelf at the store while coconut cake goes stale on the shelf beside it. Which cake will be ordered by the dealer to sell again next week?



REGISTER OF MERIT POLICY

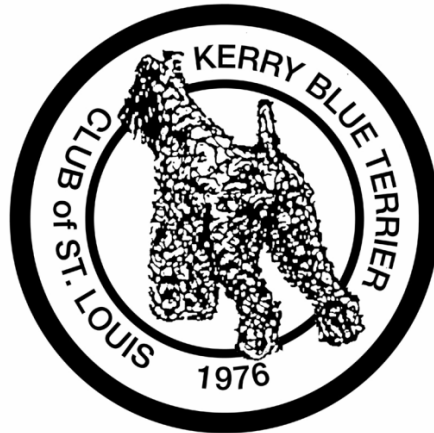

## **Factor XI Mutation**

Several hereditary bleeding disorders have been identified in many different canine breeds and involve clotting (coagulation) factor deficiencies, platelet disorders, and von Willebrand disease. Coagulation factor XI (FXI) deficiency in the Kerry Blue Terrier breed was first described in the 80's (Knowler C, Giger U, Dodds WJ, Brooks M, JAVMA, 205: 1557, 1994). Since then affected dogs have been recognized on a regular basis, but the distribution and frequency of this bleeding disorder is unknown in Kerry Blue Terriers. The defect is inherited by an autosomal trait with dogs homozygous and possibly heterozygous having an excessive bleeding tendency. Very recently the mutation causing FXI deficiency in Kerry Blue Terriers has been identified at the University of Pennsylvania now offering the opportunity to screen animals in the breed at risk for this mutation.

Dogs with hereditary FXI deficiency may exhibit an increased bleeding tendency following trauma or surgery (even after too short nail clippings or simple surgical skin mass removals) or rarely appear to develop spontaneous bleeding. Some FXI-deficient dogs may bleed excessively after one but not the other event. At this point we cannot predict which of the affected dogs actually will be seriously bleeding. Furthermore as some remain completely asymptomatic, the diseased/mutant gene (allele) may be unknowingly passed on to the next generation not only via heterozygous but also homozygous affected dogs. Carriers or heterozygotes have one mutant and one normal gene (allele) and homozygous animals have two mutant copies of the diseased gene (allele). It is currently believed that homozygously affected animals have a more severe bleeding tendency.

Screening Kerry Blue Terriers with a clotting test (isolated prolonged PTT or ACT assay) may suggest FXI deficiency to a veterinarian, and measurement of low plasma FXI coagulant activity could confirm a diagnosis of FXI deficiency at a reference laboratory. However, coagulation tests generally require blood collection in citrated tubes, which is immediately separated and shipped making it impractical as a simple screening test. Only a small number of Kerry Blue Terriers have been tested so far, and hence the frequency and bleeding tendency remain to be elucidated.

A mutation-based DNA test to screen for FXI deficiency in Kerry Blue Terrier dogs has just been developed by Drs. Eva Tcherneva and Urs Giger and has been established at their laboratory at the University of Pennsylvania School of Veterinary Medicine. This test can clearly identify homozygous and heterozygous affecteds, as well as normal (also known as clear) Kerry Blue Terriers. We recommend testing of any Kerry Blue Terrier dog with signs of bleeding, as well as its relatives. Furthermore, it is advisable to screen any Kerry Blue Terrier dogs prior to breeding to limit the spread of this bleeding disorder, particularly via any popular sires. Carriers could still be used in future breeding programs. Knowing which dog is a carrier or normal (clear) will allow the targeted breeding of carriers with desirable traits to normal dogs without ever producing homozygous affected dogs, as long as the offspring are also tested and only clear dogs used thereafter.

The Josephine Deubler Genetic Testing Laboratory at the University of Pennsylvania (Dr. Urs Giger, director; Mr. Adam Seng, research specialist) is offering screening for FXI deficiency in Kerry Blue Terriers. Samples suitable for this DNA test include 1-2 ml EDTA-anticoagulated blood (preferable) or 2-3 cheek swabs (with special cytobrushes). Brushes and test submission forms are available from us ( <http://www.vet.upenn.edu/penngen> ) or through the United States Kerry Blue Terrier Club (<http://www.uskbtcc.com>) or Kerry Blue Terrier Foundation ( <http://www.kerryblues.info>) or directly from us. Test submission forms can also be downloaded from these websites. For more information on canine FVII deficiency, please contact Dr. Urs Giger (215-898-8894/8830; [penngen@vet.upenn.edu](mailto:penngen@vet.upenn.edu) ). Blood and dried cheek swab samples, along with test submission forms, pedigree and other information, may be submitted to Dr. Urs Giger/FXI Rm 4006, Ryan Veterinary Hospital , University of Pennsylvania , 3900 Spruce Street , Philadelphia , PA , 19104-6010 . Test results are generally available within 3 weeks from receipt of samples and are sent only to submitter of samples. All information is kept strictly confidential. ## Instructions for Sample Submission

Please follow these instructions to obtain a DNA sample and remember to provide all the necessary information when you send your animal's sample. You need to send either a blood sample or cheek swabs but not both and we prefer, a blood sample. To receive swab kits, please email [penngen@vet.upenn.edu](mailto:penngen@vet.upenn.edu) number animals to be tested, name and address. If you have further questions contact us via this email or call (215) 898-3375 or (215) 898- 8894.

### **Blood Sample Collection** (performed by a veterinary clinician or nurse)

1. Label one EDTA (purple top) tube with owner's last name and animal's name (or AKC#)
2. Take a 1-2-ml blood sample.
3. A blood sample must be kept cold but not frozen until shipping.
4. Complete required submission form and mail with sample.
5. Mail tube in mailer by 2-day delivery or regular service. Your veterinarian may have special Styrofoam containers or cardboard mailers to send blood tubes in a Ziplock™ bag in bubble wrap for protection.
6. For international shipment a customs declaration and proforma invoice must be filled out (see our website).

### **Cheek Swab Sample Collection**

1. To avoid contamination with food, do not feed the animal at least three hours before you collect the sample.
2. Wash your hands before you collect the sample.
3. Label the packages that contain the cheek swab brushes with the owner's last name and the animal's name and/or AKC number.
4. Open the end of the swab package that shows the word, "peel," printed on it. Be careful not to touch the brush end as you remove the swab.
5. You may also wish to ask a second person to gently restrain the animal's head while you collect the DNA sample.
6. Insert brush end between the animal's gums and inside of the cheek. Roll the brush on the surface of the inside of the cheek for 15-20 seconds. Make sure that the brush is in contact with the cheek and not just with the saliva.
7. Return brush to its original package, allow it to dry, and then tape the opened end shut.
8. Repeat steps 3-5 for the second brush using opposite side of mouth. Two to three swab brushes are needed for each animal tested.
9. If you plan to test another animal, remember to wash your hands before you start with the next dog.
10. Secure brushes from each animal tested in a separate Ziplock™ bag.
11. The samples can be mailed by regular or express mail to address below.

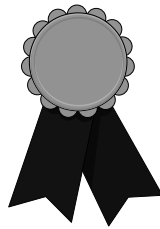

2. Thirty (30) days after publication in BLUEPRINTSsm, your application and any members comments will be submitted to the Board of Governors for consideration.
3. You will be promptly notified, in writing, of the Board's action.
4. You will be provided with a copy of the approved Constitution and Bylaws.

This Membership process can take up to six (6) months or more, due to the publication of BLUEPRINTSsm three times per year, please be patient. Note that your check may be cashed prior to your being elected to membership. This does not automatically elect you to membership. If for any reason, you are not elected to membership, your application fee will be refunded.

**THE UNITED STATES KERRY BLUE TERRIER CLUB  
CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

**I. RESPONSIBILITIES AS A MEMBER**

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.

- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.

## II. RESPONSIBILITIES AS A BREEDER

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names, and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- **Be prepared to assume lifetime responsibility for any litter produced.**

## III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

## IV. ENFORCEMENT

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
