So much for the thought of relaxing for the Florida Kerry Club. They did another excellent job with the Meet the Breeds booth. I have to specifically thank Barb Beuter for presenting at the Judges seminar at Eukanuba. The club must continue to educate our prospective and current judges as I said in my November message. Thanks to Carol Kearney also because we now have a standard set of documents for our presenters to use.

January then started the local Florida circuit and all the shows beginning in early January. The worry the Florida club had as well as the national club was how will the move from Brooksville to Ocala affect entries? The answer? Not at all. All weekend long which included the central Florida specialty and the National Traveling Specialty, there were 40-43 Kerries entered. Great turnout! I had the time to travel for the weekend and the opportunity to enjoy the hospitality of the Central Florida club members during the shows and at the dinner. They know how to run a raffle. I never saw so many items donated. The Silent auction was also a big hit. I had a wonderful time. The next Traveling will be 2014 in Texas. There are a couple of major challenges/goals and plans that we are or will look to address over the next year or two. One of the largest undertakings will be redoing our USKBTC website. Over the fall and winter, the USKBTC sent out an RFP (Request for Proposal) to a number of web firms asking for an estimate on updating our web site. We determined a budget that we would like to stay near. The firms we approached were many of the same ones that the AKC looked at to redo their website. We settled on a firm and we have begun discussions to establish a project plan and the scope of the delivery that the US club will expect. We have not had an updated look to our website in a number of years and I am really excited. The new look web site will not only be user friendly for our members but will have a new look and feel for people looking for the right breed. We will take into consideration suggestions we have received like password protection of some personal data, streaming capability, links to pictures, etc... Speaking of pictures, Carol Kearney will be looking for pictures demonstrating herding, dock diving, therapy, obedience, rally, etc... We have a number of pictures from our Meet the Breed booth in Florida, but we would like to be able to select from a larger pool. Keep an eye out for the e-mail.

Another goal/plan is to inject a new life into our Futurity/Maturity held in October. Gigi Lorentz-Reiling will be our new Futurity Chairperson and she is working with the Judges Nominating committee on selecting a panel of judges. We are hoping to have a greater participation than the past several years. We have to remember another draw at the Futurity is the Kerry Boutique. If you have something "Kerry" or Kerry related or just plain artsy crafts, please arrange to have space at the Boutique.

Finally, a new USKBTC Handbook. We have not published a new one in over 10 years. This year Richard Basler worked with the AKC on updating the Kerry Blue information in the AKC Dog Book. We have to stay up to date with changes in the Handbook and a member of the Board could sit on the committee and bring direction. This would be a big undertaking so don't take the work that is needed lightly. Remember it takes a village to create a handbook.

- ◆ Meeting was called to order by John Garahan and all were thanked for attending.
- ◆ Members in attendance: John Garahan, Stephanie Clark, Diane Lee, Scott Kellogg, Janie MacBryde, Nancy Vance, Linda Pheasant, Priscilla Schwenk, Carl Ashby, Heidi Cregor, Monica Adair, Reita Nicholson, Gerry Yeager, Martha Nazak
- ◆ Motion was made by Martha to change the order of business, and the motion carried by Janie.
- ◆ New Board Members were introduced and all were approved and sworn into office. Name tags will be ordered for new board members.

***New slate of officers for 2013:***

Treasurer: Carl Ashby

- ◆ **Health & Genetics Committee:** Scott reports a seminar was held at the Pittsburgh Traveling Specialty with over twenty attendees, and led by Dr. John Verstegen. It was determined expenses of this seminar go to Charitable Funds.
- ◆ **Charitable Funds Committee:** Linda shared a balance sheet with the board and indicates the Christmas card inventory is low and needs to be updated on the website to boost sales that support this committee. Also, a tri-fold brochure is needed.
- ◆ **Membership Committee:** Martha asked the question as to why membership cannot be 'open'. Board agreed that the wording needs to be changed for 'full' membership. Junior members will be defined to be between age 0-18 years, affiliate Memberships will include 'puppy people' where they are offered a free 6-month membership, then can apply for full membership when expired. Nancy made a motion to accept, Linda second. 1 opposition, 8 approved, and 1 abstained. The guidelines will need to be reworded, but there will be no By-Law changes.
- ◆ **Rescue Committee:** John spoke on behalf of Tuesday and indicates "Lily" now resides with the Hanna's and there is a possible home for her. "Murphy" has been transported and successfully

handed over to Tuesday while in PA. It was suggested all provide Tuesday with guidance going forward and Linda asked ALL expenses pertaining to rescues be sent directly to her.

John stressed that Chapter clubs should be the first line of rescue for our KBTs, with those areas of low population density be forwarded to the National club. John agreed to mail the Chapter clubs a letter to explain how they need to step up first and then the National Club secondly, with financial help available from Charitable Funds. It was also determined that we have no liability insurance for our rescue people, so we need to provide 'hold harmless' letters. It was also unanimously discussed that all successful rescues need to be published and shared with the membership.

- ◆ **Treasurer's/Delegate's Report:** Carl provided the board the financials.
- ◆ **Recording Secretary's Report:** Charlene was not in attendance to present.
- ◆ **Corresponding Secretary's Report:** MCKC 2012 weekend was well underway thanks to the efforts made by Bill Kearney, and he made arrangements to pass along a binder of needed information to Nancy.

**OLD BUSINESS:**

- ◆ **Annual Meeting:** Before dinner on Friday, Emmie Jones will speak regarding her trophy from 1971.
- ◆ **Membership Re-instatement:** Carl led the discussion and indicates any membership that has expired can be reinstated if it's within one year, if paid current on all dues, and the original sponsor agrees to sponsor again. Carl indicates this needs to be submitted into By-Laws for a future vote. Stephanie Clark also asked for an exact due date for dues to expire, and it was indicated that date would be July 1st of each calendar year. The changes to membership reinstatement were unanimously approved by the board.
- ◆ **Charitable Funds Board:** Linda indicates there needs to be a new chairman with new ideas and new energy. Barb Beuter was suggested to be on this committee. It was also mentioned that this committee work to manage future estate donations.

**NEW BUSINESS:**

- ◆ **Columbia Terrier Show:** The board voted and approved the sweepstakes for the club, as Bill received an email to support this show.
- ◆ **The Rocky Mountain Show** has now been ap-

proved by AKC to host a KBT B-match.

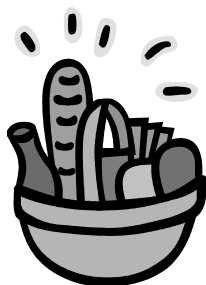
- ♦ **New Judge Selection Committee:** A new Chair is needed, and Priscilla and Martha agreed to be on this committee, with hopes Barb Beuter would join, as three members are needed. This committee would decide Futurity and Traveling Specialty judges from the top 32 names previously selected. It was also determined that an 'honorarium' fee would be given to those judges that judge our breed at MCKC. Scott indicated that the trophy list of awards to be presented would need to be published to each host club.
- ♦ **Futurity Committee:** Gigi Lorentz-Reiling, Monica and Reita will be on this committee and there was discussion to move the Futurity from Hatboro to MCKC.
- ♦ **Nominating Committee:** Scott was appointed the new chairman, with Linda and Reita on this committee.
- ♦ **Meet the Breeds:** Nancy and Reatha Omodio will be designing and hosting the booth at Florida's Eukanuba show. The AKC contact is Gina DeNardo.
- ♦ **USKBTC List:** Diane Harper would be a good choice to produce a video with her experience in filming documentaries
- ♦ **Mid Year Meeting:** It was determined that there would be a need to hold a conference call amongst board members in April. John will work out the details and update the board with his findings.
- ♦ **Annual Dinner:** Current Chairman is Anne Marie Flynn-Fierke, and plans are to ask her again to organize this event for 2013. A new location is being considered, but the deposit at Fisher's should be held. Scott agreed to call Carol Brown and Robert Black to assist. A mini-van was suggested to offer transportation to members traveling with RVs, and the board suggested the club pick up the \$60 +/- cost of this convenience.
- ♦ **Relocation of Traveling Specialties:** It was suggested by Carl the country be divided into three 'pods', with the traveling offered once a year, in addition to MCKC as a National, and the rotation to be re-evaluated by Carl and John. ## **Frequently Asked Futurity Questions**

1. What is the eligibility or cutoff birth date for litter nomination?
  - A. The litter must be born six months prior to the show date, for example the show date for 2013 is Oct 5<sup>th</sup>. Litters must be born on or before April 5<sup>th</sup>, 2013 to be nominated.
2. Is the use of a professional handler allowed?
  - A. Yes, but be sure they are present on the show grounds no less than 30 minutes prior to the published Futurity start time of 12pm local time. The event will not be delayed waiting for a handler. (Most handlers go to the Devon show and are challenged to make the noon start time.)
3. What are the restrictions on Futurity judges?
  - A. Judges may exhibit at the shows prior to the Futurity, as long as the person judging the Futurity **DOES NOT HAVE AN ENTRY** competing in the **puppy classes up to 18 months** at the shows the days before the Futurity.
  - B. As a courtesy to the exhibitors, we ask that the Futurity judges not critique the puppy classes of the previous day's shows, this is self-regulated. Please excuse yourself from conversations that critique possible Futurity entries.
  - C. Futurity judges are asked to abstain from judging chapter club sweepstakes six months prior to the Futurity.
  - D. Judges may nominate a litter for the year they are judging, keeping in accordance with the Maturity eligibility requirements for the next year.
4. What are the restrictions for Futurity volunteers?
  - A. Futurity volunteers, other than judges and score keepers, may nominate, enter and exhibit. This is a non-regular event and not governed by AKC rules for Show Superintendents, Show Chair, Committee members or event volunteers.
  - B. Futurity Judges and Score Keepers may not enter or exhibit at the Futurity for the year they are keeping score. They may nominate a litter in the current year keeping in accordance with the Maturity eligibility requirements.
5. How many entry forms do I have to complete? What are the due dates?
  - A. There are two forms you need to complete. First, you need to complete the litter nomination form, due by June 30<sup>th</sup>, regardless of the year. The second form is the individual entry form, due by the second Saturday in September of the current year.
  - B. Maturity entries only need to complete the entry form for the current year.
6. How long does the Futurity judging take?
  - A. This is the toughest question to answer. There are always two judges for each class, but the class size varies. The scores have to be tallied and placement awarded, if there isn't a tie score, before the next class can begin. You could use a rough rule of ten minutes per dog to be judged. Typically the Futurity takes three to four hours, that's why we have lunch available.
7. What is the age cutoff for the Maturity?
  - A. 30 Months. The classes are 18 to 24 months and 24 to 30 months.
8. How can anyone help?
  - A. Make a trophy donation. Contributors are listed in the catalog.
  - B. Donate items for the exhibitor gift bag
  - C. Help sell or distribute catalogs
  - D. Volunteer to ring steward and present trophies
  - E. Help set up the ring, stuff exhibitor gift bags, set up trophy table
  - F. Volunteer as the official photographer, to photograph the winners and send them to Blueprints editor.

If for any reason, you are not elected to membership; your application fee will be refunded.

### **THE UNITED STATES KERRY BLUE TERRIER CLUB CODE OF ETHICS**

This document defines the ethical standards to which we ascribe as a condition of membership in the United States Kerry Blue Terrier Club (USKBTC). Membership is a privilege conferred by the Board of Governors, acting for the Membership, upon those individuals who meet the high standards set forth in the Club Constitution and Bylaws and this Code. As members, we are individually charged with complying with this code and demanding similar compliance of all other members. We must hold the interest of the Kerry Blue Terrier superior to our own in exercising the responsibilities that accompany the privileges of membership.

#### **I. RESPONSIBILITIES AS A MEMBER**

- Members of the USKBTC, as Stewards to the breed, have the obligation to protect and serve the best interests of the Kerry Blue Terrier at all times. A member's every action should reflect credit on themselves, the USKBTC and, above all, the Kerry Blue Terrier.
- The approved standard for the breed is the fundamental imperative guiding our actions. Members have the obligation to protect and serve these standards as a condition of membership.
- Members must be familiar with and comply with the rules of the American Kennel Club (AKC); the Constitution and By-laws of the USKBTC; and (as appropriate) the rules established by any member club of the USKBTC.
- Members will observe the highest standards of conduct and sportsmanship at all times. Whether as a breeder, exhibitor, or spectator, they shall conduct themselves in a manner that reflects positively on the Kerry Blue Terrier, dogs in general, and the sport of showing dogs.
- Members shall maintain the highest standards of health and sanitation for their own Kerry Blue Terriers, as well as for any other animals in their possession or entrusted to their care. They shall demand the same high standards of others, members and non-members alike.



## **II. RESPONSIBILITIES AS A BREEDER**

A Breeder shall:

- Be guided at all times by the approved standard for the Kerry Blue Terrier and shall consider breeding only those specimens that conform to the standard.
- When contemplating breeding a litter or providing the services of a stud dog, strive toward maintaining breed type and producing dogs of exceptional quality, temperament, and condition. Breeding or supporting breeding to a lesser standard is not acceptable.
- Use for breeding only those dogs that are healthy and free from serious congenital and hereditary defects. Refrain from further use, any bitch or stud dog that has developed such a health problem or produced any serious inherited defects detrimental to the offspring and the overall well being of the breed.
- Not use a bitch for breeding prior to reaching eighteen (18) months of age (preferably 24 months) or older than eight (8) years of age. A bitch should not be bred more than two (2) out of three (3) consecutive heat cycles, nor produce more than five (5) litters in her lifetime. Recognizing the variations in heat cycles and sizes of litters, valid exceptions may exist, however it is incumbent on the breeder to exercise good judgment in exercising such exceptions.
- Not sell puppies to pet shops either outright or on consignment; supply puppies for auctions, raffles, or other such activities; refrain from selling to persons whose intention (either known or suspected) is to resell or use the puppy in a breeding program not complying with this code of ethics. The breeder shall ensure that the prospective buyer is prepared to provide the same degree of care required of members of the USKBTC. The Code of Ethics should be provided and discussed with potential buyers as part of a thorough screening process. All buyers should be encouraged to become members of the USKBTC and member clubs.
- Promptly apply for AKC registration of the litter. Puppies should not be sold prior to reaching ten (10) weeks of age (preferably 12 weeks). The sale of every dog shall include a signed registration or registration application (Blue Slip), and a four-generation pedigree. Any exceptions to these requirements, or valid restrictions or limitations imposed as conditions to the sale (e.g., no breeding) must be agreed to in writing by both parties at the time of sale. It is strongly recommended that a written agreement accompany all sales. Buyers should be provided with assistance and support in the setting of ears and in learning proper grooming. If the buyer is not located in the same area, the breeder should make arrangements with another USKBTC member in that area to assist the new owner.
- Provide with each sale, a record of dated and types of immunization given, immunizations required, and veterinary health records. Instructions should be provided, preferably in writing, on diseases and hereditary factors related to the breed, proper medical care, feeding, and grooming. Providing a copy of the current USKBTC Handbook represents a means of conveying this type of information, and is a sound investment on the part of the breeder. No puppy should be sold without either temporary or permanent protection against distemper-hepatitis and parvo. Puppies should have a veterinary examination, and worming if required, before sale.
- Maintain accurate and complete records of stock, matings, pedigrees, show records, and transfers. Breeders are responsible for conducting research on their pedigrees to ensure correct ancestry, accurate spelling of names and correct registration numbers. Breeders should be familiar with and comply with all record keeping requirements required by the AKC. Litter registration applications must be correct and promptly requested. Individual puppy registration should be completed in a timely manner.
- Shall not engage in false or misleading advertising or other misrepresentations with respect to their own breeding. They shall not malign others by making false or misleading statements regarding another member's dogs, breeding practices, or person. Advertising should not be worded to attract undesirable buyers nor encourage raising dogs for profit.
- Consider the growing problems related to excess dogs ending up in animal shelters and should exercise sound judgment and prudent restraint in their breeding programs. Litters should be limited to numbers that are consistent with achieving a sound breeding program and the best interests of the Kerry Blue Terrier.
- Be prepared to assume lifetime responsibility for any litter produced.

## **III. RESPONSIBILITIES AS AN EXHIBITOR OR HANDLER**

- Act professionally at all times in caring for and exhibiting any dog in your charge.
- Do not engage in any questionable contact with judges prior to exhibiting under them.
- Comply with AKC Rules and Regulations for Dog Shows, Obedience Trials, Field Trials, and The Guidelines for Dog Show Judges.
- Exhibit or handle only those dogs that conform as closely as possible to the approved standard.
- Do not indulge in the practice of making "kennel majors", or exhibiting filler dogs that they know themselves to be unworthy of championships, for the purpose of finishing dogs. Such practices lessen the meaning and value of a championship and do not serve the breed.

## **IV. ENFORCEMENT**

- The USKBTC expects adherence to this Code of Ethics and blatant disregard of these standards will not be condoned. Violations of the standards are not in the best interests of the Club or the breed. Such behavior can serve as a cause of imposing discipline or terminating membership if charges are brought before the Board of Governors in accordance with the procedures as defined in Article VI (Discipline) of the USKBTC Constitution and Bylaws.
- Article VI addresses the specific procedures for proffering charges; the hearing process; and the rights of the parties involved. Each member is expected to be fully familiar with this very important provision of the By-laws.
